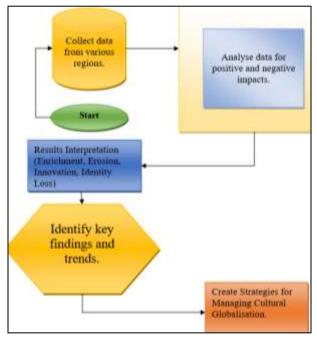


Fig 2: Proposed Flowchart

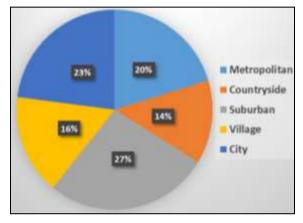


Fig 3: Influence of cultural globalization on local traditions pie

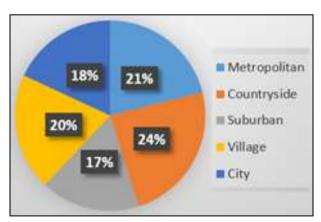


Fig 4: Positive impacts of cultural globalization (Percentage of Respondents)

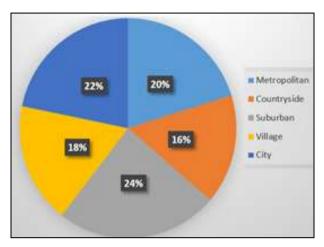
